The Customer

1. General rules. Within the port area for lacuale use in state property concession to the company Trasmarm s.n.c. (n. CADP/PA001, issued by the Municipality of Lazise on 13.01.2022, prot. No. 992/2022), the following rules apply:

- ❖ The Customer is required to occupy only his own water space, placing his boat straight, perpendicular to the pier.
- ❖ It is mandatory to use at least four fenders, two per side (one front, one rear). However, it is advisable to use a greater number of these, in order to safeguard even better your boat and that of the nearby berth.
- ❖ We recommend the use of mooring ropes (the company Trasmarm s.n.c. is available for any type of advice/clarification).
- ❖ The Customer is obliged to deliver to the company Trasmarm s.n.c. a copy of the insurance of the boat, valid for Italy, to cover any damage to their boat or that of third parties.

2. Liability. The company Trasmarm s.n.c. is exempt from any kind of liability (total or partial theft, fire, vandalism, atmospheric events including displacement of the buoy and its components, such as hooks, chains, etc.) concerning boats moored within its berths.

In the case of early release of the berth, the Customer will not be entitled to any refund by the company Trasmarm s.n.c.

3. Arrival and Departure. Arrival can only take place after 10.00 on the first day of booking. If you need to take advantage of the crane, it is advisable to call a few days in advance the telephone number + 39 324 7719304 to agree on the launch time.

The departure must necessarily take place between 09.00 and 10.00 of the day following the last day of booking (eg: if the reservation was requested until 01 May, the berth must be vacated between 09.00 and 10.00 of 02 May). If haulage requires the use of the crane, it is advisable to call a few days in advance the telephone number + 39 324 7719304 to agree on the time of hauling.

4. Deposit and balance. After receiving from Trasmarm s.n.c. confirmation of the availability of the desired berth during the requested dates, to perfect the reservation and then lock the place, Mr. customer is required, within 72H (3 days), to pay a deposit, equal to 50% of the total amount of the service requested by bank transfer* and to communicate to Trasmarm s.n.c. his complete data (Name, Surname, Residence, Tax Code or similar)/the complete data of your company (name, company name, registered office, tax code and/or VAT number, recipient code), by sending an e-mail to the following e-mail address: info@trasmarm.eu. As soon as the bank transfer is received, Trasmarm s.n.c. will issue a receipt, bearing a stamp, certifying that payment has been made, followed by the issue of a regular tax invoice following the balance of the service.

The balance of the agreed rate must be paid within 24H from the placement of the boat in the berth assigned to it.

In case of cancellation by the company, which may be given only and exclusively for reasons of force majeure (e.g. insufficient water in the lake), the deposit will be fully refunded within 2 weeks from the notice of cancellation.

In case of cancellation by the Customer by 31/01 of the year to which the reservation refers, the deposit will be fully refunded within 2 weeks of notification of the cancellation to the place; in case of cancellation from 01/02 of the year to which the reservation refers, the deposit will not be refunded.

5. Reservations. Bookings are open 365 days a year. You can book a berth from 1 April of the current year to 31 October of the following year.

Until 28 February (inclusive) it will be possible to book a berth only if required for a minimum of 5 consecutive days. Bookings for less than 5 days can be made from 1 March.
